Working languages are English, Russian, and Latvian.

All research papers are peer-reviewed. All accepted papers (articles) after review will be published in the proceedings of the scientific symposium with ISBN / ISSN number and will be located on our website. Proceedings will be published in three languages: English, Russian and Latvian.

You can also upload your abstracts / papers (articles) in the registration form in the doc format.

Within 2 weeks from receiving your abstract / paper (article), we will inform you whether your article is accepted for presentation at the symposium.

During the symposium, you can use the following types of participation:

- Regular (Oral presentation)
- Poster (Demonstration of the poster)
- Attending only (Listener)

If you choose the type of participation as an oral presentation, you will be given 20 minutes (15 minutes for presentation and 5 minutes for discussion). For oral presentation, you must have Power Point presentation version on the USB Flash support. In order to avoid technical problems, you can send your presentation by email iris.latvia@gmail.com a week before the symposium takes place. All rooms for oral presentations will be equipped with the necessary technical equipment - computer (laptop) and a screen for Power Point presentations.

If your participation is a demonstration of the poster (Poster Section), please prepare a poster, which will reflect the main results of your research. The size of the poster should not exceed 80 x 90 cm. During the poster section you need to be near your poster and discuss the problems of the research work with someone who might be interested. You also need to have a few samples of your research work, so you can transfer them to the participants of the symposium who are interested in your research.

If you are just a listener (attending only), you will have the opportunity to visit the plenary session and all working sessions, as well as take part in debates and discussions of topical issues. All listeners will receive a full package of symposium materials.

Participants of oral presentation and poster session will be issued a certificate confirming the presentation of your research at an international symposium.

If you wish to participate in a symposium with oral presentation or with a demonstration of the poster (poster section), but do not want to publish your article in the proceedings of the scientific symposium, you have to send only your abstract in English.

You can submit papers (articles) in English, Russian and Latvian. Your presentation also may be available in English, Russian or Latvian.

All abstracts must be written in English.

Papers (articles) submitted for publication in the scientific journals must be written only in English.

If you wish to publish the research article in the scientific Journal "Copernican Journal of Finance & Accounting" indexed in the database Index Copernicus, EBSCO, REPEC, PROQUEST, Google Scholar, BazEkon, Sherpa/Romeo, please, send the full article no later than April 7, 2015. If the results of reviewing are positive, your article will be published and you'll receive a printed copy of the Copernican Journal of Finance & Accounting with your published article at the symposium.

If you want to publish your research paper in the **Journal of International Economic Researches**, please notify us about it no later than **September 1, 2015**, and we'll send your paper (article) for review to double blind reviewers. After the review procedure and according

to the results of the reviewer's opinion, we will notify you whether it is possible to publish your article in the Journal of International Economic Researches.

"Journal of International Economic Researches" will be sent in EBSCO, PROQUEST, VERSITA, VINITI, etc. databases.

Each participant who has registered at the symposium will receive the symposium program and book of abstracts.

Please strictly observe the terms of registration and follow the formatting instruction.

April 30<sup>th</sup>, 2015 – Submission deadline for full paper (article), if you want to publish full paper in symposium proceedings.

April 7<sup>th</sup>, 2015 - Submission deadline for full paper (article), if you want to publish your paper in "Copernican Journal of Finance & Accounting" (you'll receive a printed copy of the Copernican Journal of Finance & Accounting with your published article at the symposium)

February 20<sup>th</sup> - June 1<sup>st</sup>, 2015 – Registration of participants.

April 15<sup>th</sup>, 2015 - Early registration deadline.

June 1<sup>st</sup>, 2015 – Late registration deadline. July 7<sup>th</sup> – July 11<sup>th</sup>, 2015 – Symposium

## Information about registration and fees:

To register for the symposium, please complete the registration form and pay the registration fee.

Registration fee for the symposium is 300 EUR (early registration, before April 15, 2015). If you register from April 15<sup>th</sup> to June 1<sup>st</sup>, 2015, the registration fee is 350 EUR. After the 1<sup>st</sup> of June, 2015 registration period will be closed.

You will not be able to pay registration fee after the 1<sup>st</sup> of June, 2015, and will not be able to pay in cash during the symposium.

Full time PhD students receive a discount.

Registration fee for participation in the symposium for full-time PhD students is **200 EUR** (early registration, **before April 15, 2015**).

If full-time PhD students register in the period from April 15<sup>th</sup> to June 1<sup>st</sup>, 2015, the registration fee is 250 EUR.

If you submit a research paper, which is written jointly with one or more co-authors and co-authors come to the symposium, each co-author is a full participant in the symposium and must fill out the registration form and pay the full registration fee.

The co-authors who do not come to the symposium must not pay the registration fee and do not receive a certificate of participation in the symposium.

If a participant of symposium wants to do more than 1 (one) presentation then the fee for each additional presentation is **120 EUR**.

## Venue of the symposium

Latvia is a pearl of Baltic countries located in North Europe at the Baltic seaside. Territory of Latvia occupies 64 589 kilometres<sup>2</sup>. It is a green country with widely stretched forests and untouched nature. Latvia is known for the sandy beaches, modern seaports, excellent resorts, and ancient fishing settlements. Since old times Latvia was Europe crossing between West and East, between South and North. Therefore Latvia is a multicultural country that preserved its unique traditions. Latvia is rich in beautiful architecture and fascinating sights, and safe and healthy ecological environment.



The capital of Latvia is Riga, the largest city in Baltic countries. It is situated on both sides of river "Daugava", not far from its inflow in the Riga bay. For a long time Riga was a Gansiatic city. There are buildings of different styles from medieval architecture of old city to the modern architecture. Riga is the largest port and one of the major commercial and cultural centers. The historical center of Riga is included in UNESCO World Heritage List. In 2014 Riga became one of the cultural capitals of Europe. The main sights of Old Riga are: Dome Cathedral, St. Peter's Church, St. EKABA's Cathedral, Town Hall Square, LIVU Square, Riga Castle, and others. Dome Square is the largest square in Old Riga and it is considered to be the central square. Seven streets of Old Riga cross at this square. In summer there are many outdoor cafes, where people can relax and enjoy live music every day.

Not far from Riga (at the distance of 17 km.) you can see the pearl of Latvia – beautiful Jurmala. The area of Jurmala is about 100 sq. km. It is a famous seaside resort. The beaches of Jurmala are about 30 km long. Jurmala is a favorite place for conferences, meetings, concerts, symposiums. Jurmala is known for its unusual architecture with decors, cut on tree, buildings of country type and spa facilities.

There are residence of the President of Latvia, Museum of Yan Raynis and his wife – the poetess Aspasia in Jurmala.

The list of architectural monuments of Jurmala includes 414 buildings, and the number of historical constructions includes more than 4000.

Summer walk in the pedestrian street Yomas from Mayori to Dzintari will show you the city life rhythm. The first shop, market, and drugstore were opened in this street. Now you can see there a lot of restaurants and cafes.

## How to get to Riga and Jurmala from the airport?

International airport "Riga" is located between Riga and Jurmala.

It is possible to get from the Riga airport to the capital of Latvia by the 22nd bus which runs every 10 - 15 minutes. And in half an hour you will be already in the center of Riga. Bus fare is 1 euro 15 cents (when buying from driver - 2 euro).

To get from the Riga airport to Jurmala, it is possible to take a taxi and in 15 minutes you will be in Jurmala. Taxi fare is about 25 - 30 euro. But it is possible to use also public transport: to reach the center of Riga by the 22nd bus, then to take an electric train or a minibus which runs to Jurmala; or to go by the 22nd bus to the stop "ZOLITUDES", cross the road and take a minibus 7023 (Riga – Sloka).

Riga is located next to Jurmala. To get from the center of Riga to Jurmala or from Jurmala to the center of Riga, will take you less than 1 hour.
